

DATA PRIVACY CONSENT

By submitting the customer care form, I (as "Data Subject") grant my free, voluntary and unconditional consent to the collection and processing of my Personal Data (as defined below) relating to me disclosed/ transmitted by me in person or by my authorized agent/representative/s to the information database of fischer PH Asia, Inc. ("fischer") and/or any of its authorized agent/s or representative/s as Information Controller, by whatever means in accordance with Republic Act (R.A.) 10173, otherwise known as the "Data Privacy Act of 2012" of the Republic of the Philippines, including its Implementing Rules and Regulations (IRR) as well as all other guidelines and issuances by the National Privacy Commission (NPC).

I understand that my "Personal Data" means any information, whether recorded in a material form or not, (a) from which the identity of an individual is apparent or can be reasonably and directly ascertained by the entity holding the information, or when put together with other information would directly and certainly identify an individual, (b) about an individual's address, contact number, email (c) identification issued by government agencies peculiar to an individual which includes, but not limited to taxpayer identification number (TIN), licenses and other identification with signature.

I understand, further, that fischer shall keep the Personal Data and Information and the business and/or transaction/s that I do with fischer (the "Business") in strict confidence, and that the collection and processing of all Personal Data and/or Information by fischer may be used for any of the following purposes (collectively, the "Purposes"):

1. To track and record my inquiries, concerns, and complaints
2. To track actual resolutions to no.1
3. To process service engagement and related payments to me by fischer
4. To provide me with updates on promotions, products, and related fixings services offered by fischer
5. To track and record receipt of product samples and/or promotional materials provided to me by fischer.
6. To contact me in case of any product related concerns or after-sales services needed related to fischer products.

At the same time, I agree that the Information shall be retained by fischer for as long as necessary for the fulfillment of any of the aforementioned Purposes and shall continue to be retained for a period of ten (10) years notwithstanding the termination of any of the above Purposes.

I hereby acknowledge that I have been provided with the written notification below on my rights as a Data Subject (each, a "Right", collectively, the "Rights") in accordance with the Data Privacy Act of 2012, to wit:

- i. to be informed whether Information and/or Personal Data is being or has been processed.
- ii. to require fischer to correct any Information and/or Personal Data relating to the Data Subject which is inaccurate.
- iii. to object to the processing of the Information and/or Personal Data in case of changes or amendments to the Information and/or Personal Data supplied or declared to the Data Subject
- iv. to access the Information and/or Personal Data
- v. to suspend, withdraw or order the blocking, removal or destruction of the Data Subject's Personal Data from fischer's information database system.

I understand that as a general rule, fischer is not allowed to share my data to third party except in limited circumstances as noted below.

1. As necessary for the proper execution of processes related to the declared purpose.
2. The use or disclosure is reasonably necessary, required or authorized by or under the law.

This means fischer may share my information to the fischer IT Services, fischer group and government agencies. fischer may amend this Data Privacy Notice at any time without prior notice to ensure that it is consistent with legal and regulatory requirements applicable to how it handles my personal data.

I understand that fischer will take reasonable steps to make sure that my personal data it collects, use or disclose are accurate, complete, and up-to-date. fischer strictly enforce its privacy policy within the company and have implemented technological, organizational, and physical security measures to protect my information it holds from loss, misuse, modification, unauthorized or accidental access or disclosure, alteration, or destruction. fischer keep and protect my information using a secured server behind a firewall, deploying encryption on computing devices and physical security controls. It restricts access to my information only to qualified and authorized personnel who hold my information with strict confidentiality.

I understand that I may request fischer by a written letter or email to the Data Privacy Officer (DPO) to exercise my rights which include right to access, modify, erasure and object to processing my personal data within a reasonable time after such request through its Data Privacy Officer below:
